

Evolv "Screened by Evolv" Seal Program Terms

Effective Date: May 6, 2026

These "Screened by Evolv" Seal Program Terms ("**Seal Program Terms**") govern participation in the Evolv "Screened by Evolv" Seal Program ("**Program**"). By using a "Screened by Evolv" Seal, you agree to these Terms.

1. **Purpose of the Seal**

The "Screened by Evolv" Seal indicates that the venue or facility is an Evolv Customer (as defined below) and uses Evolv Products to screen persons and/or bags entering their venue or facility.

2. **Eligibility**

Participation is limited to customers who have contracted to use Evolv Products either directly with Evolv or through an authorized reseller ("**Customer(s)**").

3. **Badge License & Authorized Use**

Subject to compliance with these Seal Program Terms, Evolv grants Customer a limited, non-exclusive, non-transferable, revocable license to use the applicable Seal solely in accordance with these Seal Program Terms and [Evolv's Brand Guidelines](#). Customer may use and display the "Screened by Evolv" Seal only in approved formats as provided by Evolv in the following ways:

- On Customer owned and operated websites and mobile apps
- On Customer event pages on ticketing platforms
- On Customer venue doors and windows, printed tickets, playbills, handouts, and signage for Customer events.

Customer understands that the use of the Seal must be an accurate representation of the screening at their venue or facility. In each instance, the use of the Seal is only authorized to the extent that the Customer is using Evolv Products for screening. Any other use requires prior written consent from Evolv.

4. **Unauthorized Use**

The Seal may only be used in a manner authorized by Section 3 of these Seal Program Terms. The Seal may not be used in relation to venues, facilities, events, or other instances where the Evolv Products are not being actively used for primary screening purposes, or in association with non-Evolv screening systems.

5. **Scope of Screening & Responsibility**

The Evolv Products are designed to support broader security efforts and are intended to be used as one layer in a comprehensive security strategy. They are not a substitute for human judgement, operational oversight, or physical screening procedures. The Customer is responsible for security and screening policies and procedures at their venue or facility, the staffing and training for use of Evolv Products, operation of the Evolv Products, and for secondary searches if an Evolv Product alarms.

6. No Guarantee of Safety

Customer acknowledges and agrees that neither Evolv nor the Evolv Products, can guarantee the detection of all threats or prevention of all harmful events. The Seal does not imply that the venue is completely free of risk or that all threats have been eliminated, and it is not a guarantee of safety.

7. Intellectual Property & Trademark Notice

The Seal and all associated logos are the exclusive property of Evolv Technologies, Inc. and protected by intellectual property laws. Except for the limited, revocable license granted under these Seal Program Terms, no rights are granted to Customer. "Screened by Evolv" and Evolv trademarks are the property of Evolv Technologies, Inc. Unauthorized use is prohibited.

8. Compliance, Modification and Removal

Customer agrees to comply with all applicable laws, regulations, and Evolv policies in connection with Seal use. Evolv reserves the right to update these Seal Program Terms at any time or require removal of the Seal if used in a misleading or unauthorized manner. Customer agrees to promptly correct or discontinue any use of the Seal at Evolv's request.

9. Termination

Upon termination of your agreement or order document for Evolv Products, Customer must immediately stop using and displaying the Seal.

10. Limitation of Liability and Indemnity

To the fullest extent permitted by law, Evolv disclaims all liability arising out of or relating to Customer's use of the Seal or Program. Customer shall defend and indemnify Evolv from and against all claims, actions, proceedings, losses, damages, fines, penalties, liabilities, judgments, and amounts paid in settlement and the costs and expenses incident thereto (including reasonable attorney's fees) ("Losses") resulting from any third party suit, demand, or claim ("Indemnity Claim") arising out of (Customer's (or its agents' or representatives')) use of the Seal in a manner inconsistent with these Seal Program Terms.

By participating in the Program and using a "Screened by Evolv" Seal, you acknowledge that you have read, understood, and agree to these Terms.
